

#### TERMS AND CONDITIONS "ENJOY YEAR-END SHOPPING OFFERS WITH HSBC DEBIT CARDS"

# (These Terms and Conditions take effect from 01<sup>ST</sup> Dec 2023)

Customer is advised to note that participating in the Promotion program or accepting the promotional benefits offered by the program means that Customer has read, understood and accepted these Terms and Conditions.

- The "Enjoy year-end shopping offers with HSBC Debit Cards" Promotion (the "Promotion") is applied at all HSBC Bank (Vietnam) Ltd. ("HSBC" or the "Bank") branches and and takes effect from 01/12/2023 to 31/01/2024 (the "Promotion Period").
- 2. This Promotion is applicable for customers who satisfy the following condition ("Eligible Customer"
  - or "Eligible Cardholder" or "Cardholder"):

Cardholders who are holding the following debit cards issued by the Bank in Vietnam, including:

- HSBC Debit Card (6 first digits: 458440)
- HSBC Visa Platinum Debit Card (6 first digits: 458761)

(These debit cards shall be referred to as "HSBC Debit Card", "Debit Card" or "Card")

- 3. This Promotion shall not apply for cardholders if by & within the Promotion Period:
  - His/her Card is delinquent with fee,
  - Card is blocked/ closed for any reasons,
- **4.** This Promotion shall not be counted for transaction if there is at least one of below recognized (shell be referred as "**Unqualified Transaction**"):
  - Account (linked with card) has insufficient balance for that transaction,

- **5.** "Qualified Transaction" is a successful transaction recorded in the Bank's system and not recognized with any conditions mentions in article 4 of unqualified transaction. Note: SMS transaction notification is not considered as a confirmation of a qualified transaction.
